
Executive Summary

In 2025, many communities faced hate and bigotry, but Muslim Americans quickly became among the most intensively targeted groups in coordinated disinformation campaigns. Islamophobia in the United States has developed into a nationwide ecosystem of false narratives, intimidation, and political targeting that erodes public safety, suppresses civic participation, and drives discriminatory policy.

This escalation reflects two intersecting dynamics:

1. The convergence of Islamophobia and anti-immigrant sentiment under the current administration.
2. The amplification of existing Islamophobic counterterror discourse through social media, which extends pre-9/11 “counterterror nationalism,” seen during Gulf War coverage and post-9/11 War on Terror rhetoric, into a digital environment that enables Islamophobic disinformation to circulate with unprecedented speed, reach, and scale.

This report examines the national rise of American Islamophobia¹ in online spaces across the United States in 2025 especially around the orientalist and discriminatory theory of “Muslim invasion.” Our team tracked these narratives in several states from January 1 to December 31, 2025, documenting not only an increase in Islamophobic content but also a growing volume of material explicitly designed to inflame tensions and incite violence.

Methodology

For this report, our team of experts employed a mixed-methods approach, combining:

- **Quantitative analysis** using social media intelligence tools to track volume, engagements, and patterns of Islamophobic disinformation around the theme of “Muslim invasion” across 12 social media platforms² as well as manually coding a set of over 1500 posts.
- **Qualitative analysis** through a hand-coded review of content across our dataset, allowing us to identify narratives, frames, and tactics that cannot be captured by metrics alone.

Together, these methods provide both a broad overview of the disinformation ecosystem and a granular understanding of how specific messages were constructed, targeted, and amplified across the United States, particularly in five battleground states. 
Quantitative Analysis

From January 1, 2025, to December 31, 2025, we identified more than **4.72 million** Islamophobic posts targeting Muslim communities nationwide, generating **34.8 million** total engagements, including likes, shares, comments, saves, taps, and clicks, across **12** social media platforms.



The table below lists the top states associated with Islamophobia-related disinformation in our quantitative analysis. From this data set, Texas was the leading state for anti-Muslim disinformation in 2025, with approximately **279,000 posts**.

Top States Associated with Islamophobic Related Disinformation in 2025



In our manually coded national dataset of more than 1,500 online posts, we identified the ten most prevalent themes, summarized in the table below.³ The most frequently recurring theme was Muslim invasion.

“Muslim invasion” themes frame Muslims as foreigners who are actively entering the United States in ways portrayed as a civilizational threat to American identity and cultural norms. This disregards both how Black American Muslims account for 20% U.S. Muslim population, as well as the history of enslaved Muslims who helped found this country but were not free to practice their faith.⁵

The “clash of civilizations” tropes have exponentially increased in U.S. media and the public sphere since September 11, 2001, especially as focused on Arab and South Asian communities in the U.S.; often, this includes Arabs and South Asians who are not Muslim. Unsurprisingly, the rhetoric is often militarized. Influencers who are veterans or military contractors frequently frame their commentary around a sense of betrayal by the U.S. government, citing their service in Iraq and Afghanistan and claiming that, after fighting “terrorists” abroad, they have now “lost” their homeland to an alleged Muslim invasion “without a shot fired.” In this narrative, government officials are portrayed as complicit through lax enforcement of laws toward Muslim migrants.



Branding immigrants as “invaders” is a recurring motif in U.S. history, from South Asians cast as the “[Dusky Peril](#),” to Asian Americans stigmatized as the “[Yellow Peril](#)” in the early 1900s, to the sustained Islamophobia that intensified after 9/11. The current surge of American Islamophobia, accelerated during the first Trump administration and reenergized in the second, marks a new and consequential phase of xenophobic, racialized Islamophobia in American political life.

Across the dataset, this narrative functions as a core interpretive frame that anchors and amplifies other Islamophobic themes. Our manually coded dataset examined five clusters of Islamophobia-related disinformation in **Texas, Michigan, California, Florida, and Minnesota**. On the basis of our data we assessed that these states are being targeted, in part, because of their outsized influence on midterm electoral dynamics. Right-wing actors appear to be cultivating Islamophobia as a wedge issue.

Additionally, we found the following:

- **Islamophobic content is becoming increasingly widespread amongst Republican officials**, with elected officials producing or amplifying Islamophobic content to shape messaging ahead of the 2026 midterms. Our research uncovered over 25 elected officials engaging in Islamophobic rhetoric, advocating for discriminatory policies and investigations.
- **Islamophobic content frequently overlaps with anti-immigrant attacks**, including policy-oriented calls to pause visas, denaturalize citizens, and deport the foreign-born. Multiple immigrants are targeted across the country, including Somali, Sudanese, Afghan, Pakistani, and Palestinian communities.
- **Islamophobic disinformation often catalyzes discriminatory regulations, laws, investigations, and policy proposals**. This includes calls to ban Muslim immigration, efforts to label mainstream Muslim civil society organizations (e.g., CAIR) as “terrorist” entities in states such as Texas and Florida, and initiatives to restrict or stigmatize Muslim presence in public life, including anti-Sharia law measures, bans on Arabic street names, and abusive speech against Muslim schools.
- **Muslim civic engagement is increasingly targeted**, with harassment directed at Muslim candidates, voters, and elected officials across party lines (both Republican and Democratic).
- **Insufficient platform moderation is fueling a misinformation crisis**, disproportionately impacting vulnerable community members.
- **Direct incitement and violent rhetoric have become normalized**, including recurring phrases such as “call for the Crusades” and “wrap our bullets in bacon.”
- **Local government spaces are a key flashpoint**, with city council meetings and public civic events frequently used as staging grounds.

- **Right-wing influencers are deliberately provoking confrontations in public settings** (e.g., city council meetings, marches, and community “third spaces”) to generate viral content that fuels further online harassment.
- **Islamophobic narratives frequently arise as a central component of mainstream white Christian nationalist slogans, memes, and influencers.** White Christian nationalism is a political ideology blending white supremacy, American ethnonationalism, and a belief that the U.S. was founded as, and should remain, a Christian nation.⁶

Recommendations

1. **Define all faith-based electoral disinformation as a civil rights and voter access issue.** Treat anti-Muslim disinformation, intimidation, and targeted harassment of candidates and voters as an election access and equity issue with clear response protocols to ensure fair and equitable elections.
2. **Implement more rigorous platform enforcement during election cycles.** Create more rapid takedown/escalation channels for election-related hate speech and disinformation, limit recommendations or reach for repeat offenders, and apply consistent penalties, including demonetization. What exists is insufficient to deal with what is occurring on all platforms. These protocols should apply not only to English-language content in the U.S. electoral context, but should be localized and developed for each of the different languages, cultures, and regions a platform serves, as many of the issues we describe here repeat globally and are gravely under-addressed.
3. **Protect Muslim candidates, election workers, and community leaders.** Provide threat monitoring, doxxing response, security planning, and legal support (with standardized reporting pathways and referrals for credible threats) to all Muslim candidates, election workers, and community civic engagement organizations.

6. Not all White Christian nationalists are explicitly white supremacists who openly assert racial superiority; however, they typically treat white Christianity as the default basis for legitimate belonging and political leadership in the United States, tolerating nonwhite and non-Christian communities only when those groups affirm a white Christian vision of national rule. Likewise, not all white Christian nationalists are dominionists who advocate a formal theology of Christian supremacy, but they still frame Christianity as essential to the nation’s identity and claim the right to marginalize or exclude those who do not conform.

4. **Shut down provocation-for-virality in civic and election spaces.** Strengthen rules and enforcement at city councils, school boards, marches, and polling sites to prevent harassment, filming-as-intimidation, and coordinated disruptions.
5. **Increase transparency for political influence and “soft ads.”** Expand disclosure requirements for funders, targeting, and AI-generated content across political ads and influencer-style issue content; maintain searchable, publicly accessible ad libraries.
6. **Disrupt the funding and networks behind Islamophobic campaigns.** Demonetize repeat hate actors pushing Islamophobic narratives, enforce brand-safety standards, and identify coordinated networks that generate offline confrontations to drive online harassment.
7. **Inoculate communities with rapid, trusted information through prebunking.** Fund multilingual voter-information and prebunking campaigns, equip local partners with rapid response toolkits, and operate clear reporting channels for intimidation and disinformation.
8. **Consistently enforce laws against threats, stalking, and voter intimidation.** Prioritize the prosecution of credible threats and online-to-offline escalation, improve evidence preservation and data sharing, and coordinate civil rights enforcement across jurisdictions.
9. **Establish and resource multi-racial, interfaith coalitions to counter the mainstreaming of white Christian nationalism** through coordinated public education, rapid response, civic engagement, and community safety initiatives.
10. **Fund and support existing community-led safety initiatives for impacted Muslim communities** that resource leaders, organizations, religious institutions, and allies to build mutual aid, digital security/disinformation support, and community safety networks. These programs should prioritize prevention, care, and resilience while avoiding expansion of surveillance or policing infrastructures.

The conspiracy theory of a supposed “Muslim invasion” spreading across online and offline spaces illustrates how unfounded narratives can shape public perception and reinforce anti-Muslim sentiment in the United States. Social media platforms and digital forums have played a significant role in normalizing these ideas, blurring the line between opinion and fact. As evidenced by the report, these claims persist despite the absence of evidence. They are increasingly amplified through online spaces, where

disinformation and hate-driven content spread rapidly and reach wide audiences, especially with the help of right-wing influencers and elected officials. Addressing this issue involves examining how misinformation circulates online, strengthening media literacy, encouraging more accurate and responsible public discourse, and demanding timely responses from platforms and those in positions of power. Limiting the influence of such narratives is an essential step toward changing the culture and ensuring that those already targeted by hate and prejudice are not marginalized and discriminated against further.

As the nation moves into yet another election cycle, public discourse is once again shaped by anti-diversity talking points, anti-Muslim conspiracy narratives, and sustained attacks on Muslim Americans. In this climate, references to Sharia law and an Islamic invasion are routinely used as a strawman for broader cultural fears. These narratives are not new; rather, they recycle long-standing anxieties about demographic change and social pluralism. Ultimately, this fixation reveals a more profound discomfort with an increasingly diverse American society, in which the presence of multiple cultures, religions, and perspectives challenges a narrow vision of national identity.

We hope this report both documents the harm and supports community and government stakeholders in addressing it, including by developing meaningful processes for accountability, repair, and healing. This kind of hate speech not only harms its direct targets, it corrodes democratic life itself. We have faced similar moments before, and it is our hope that we can once again turn the corner together.



Introduction



These breakthroughs reflected meaningful progress in democratic participation, pluralism, and civic engagement. Yet, rather than being recognized as ordinary exercises of constitutionally protected political activity, they were systematically reframed by a growing right-wing disinformation ecosystem as evidence of a fabricated “civilizational crisis” and a so-called “Muslim invasion.”

Through coordinated narratives, conspiracy rhetoric, and targeted online hate, this ecosystem has sought to delegitimize Muslim officeholders, intimidate Muslim and South Asian communities, and erode public trust in

In 2025, Islamophobic disinformation in the United States reached a new and dangerous peak. Its escalation closely tracked a historic surge in Muslim civic participation nationwide. There were [76 Muslim candidates](#) on ballots across the country, resulting in 38 electoral wins. Among these were milestone victories: Zohran Kwame Mamdani became New York City's first Muslim and South Asian mayor; Ghazala Hashmi was elected as the first Muslim woman to statewide office in Virginia; and Mohamad “Mo” Baydoun became mayor of Dearborn Heights, Michigan.



multiracial democracy itself. These disinformation narratives were also part of a much larger wave of generalized anti-Muslim hate, the extreme nature of which corrodes social harmony and can, on many occasions, incite violence.

It is critical to break the silence about the severity of this threat and to develop a coordinated national strategy to counter the disinformation and the violence it fuels. Many Muslim Americans are living in fear, and for some, the escalation is retraumatizing, echoing the discrimination and hostility that followed 9/11.

This excerpt from Megan Kelly's podcast is an egregious example of viciousness. In this clip below, she says the following: *“And the Muslims, let’s be honest, they are breeding like rabbits. That is part of their mission: to have kids, have six, seven, eight, and win by multiplication. Christians need to have babies. Sorry, but we do. Sorry, but no more Muslims. We’re done. Our values are not aligned. They are just not. I have Muslim friends. It’s nothing against them. The individuals are fine. The friendships are fine. But Islam is not compatible with the West. They should stay in countries that don’t care about keeping church and state separate, that don’t care about women’s rights. They should stay in countries that don’t care about free speech. They should stay in countries where Islam can fester and grow. It’s great if that is your thing. If you like female genital mutilation, you might really enjoy an Islamic country. Or if you’re a woman where you’re covered up to your eyeballs, yeah sure, maybe living in the Middle East is your thing. But it’s not my thing. It’s not America’s thing. It’s not something we should encourage or want in the West, or at a governmental level.”*

This report examines how this disinformation emerged and what it reveals about the evolving architecture of hate in U.S. electoral politics. Drawing on research across Texas, Michigan, California, Florida, and Minnesota, we identify the dominant narratives, trace how they spread across platforms and influencers, and document how online campaigns translate into offline harassment and violence, civic disruption, and discriminatory policy

pressure. The report also provides a clear-eyed view of the white Christian nationalist social media ecosystem working to mainstream extremist and, at times, explicitly violent talking points. White Christian nationalism is a political ideology that fuses white supremacy, American nationalism, and the belief that the United States was founded as, and should remain, a Christian nation. In practice, it frames religious and racial diversity as a threat, exploits “law and order” propaganda, and seeks to reshape public policy around racial and ethnic exclusionary notions of belonging.

As this report demonstrates, attacks on Muslim communities are often the canary in the coal mine for broader threats to American democracy. It is clear that Islamophobic narratives frequently arise as a central component of mainstream white Christian nationalist slogans, memes, and influencers. White Christian nationalism is a political ideology blending white supremacy, American ethnonationalism, and a belief that the U.S. was founded as, and should remain, a Christian nation. Proponents advocate for White Christian nationalist values as the foundation for laws and policy. They imagine America as divinely chosen and threatened by those who are not European, white, and Christian.⁷ Part of what makes the themes of Muslim invasion so compelling is that they dovetail with preexisting notions in white Christian nationalism of the Great Replacement Theory⁸ and the threat that Muslims and other immigrants represent in contributing to white genocide.



It is especially heartbreaking to see these narratives increasingly mainstreamed, as documented throughout this report. For not all White Christian nationalists are explicit white supremacists who openly assert racial superiority. However, they often treat White Christianity as the default basis for legitimate belonging and political leadership in the United States, tolerating nonwhite and non-Christian communities only when those groups affirm a White Christian vision of national rule. Likewise, not all White Christian nationalists are dominionists who advocate a formal theology of Christian supremacy, but they still frame Christianity as essential to the nation's identity and claim the right to marginalize or exclude those who do not conform.

We believe that clearly understanding these arguments and the stakeholders who participate in these discriminatory discourses create opportunities for prevention, including violence disruption, prebunking, de-escalation, and pathways toward repair and healing. We hope this report helps advance those outcomes.

In the sections that follow, we examine narratives across five states and the District of Columbia. The Appendix documents our methodology, the elected officials and influencers involved and provides examples of the memes we coded for reference.

The 5 States We Conducted Narrative Analysis




Michigan

Michigan's large Muslim population has made the state's residents a persistent target for anti-Muslim narratives, with Dearborn serving as a central focal point. Home to more than 241,828 Muslims (about 2.4% of the state), Dearborn, a Detroit suburb, is a hub for Arab Americans, particularly of Yemeni and Lebanese descent.⁹ They constitute approximately 55% of the residents. The city's prominent Muslim and Middle Eastern presence in public life and local institutions, including the call to prayer, Arabic signage, and representation in municipal agencies and law enforcement, has repeatedly been exploited by white extremist actors to frame diversity and civic inclusion as a threat. The reality is that diversity is an ordinary part of American life, reflected in Chinatowns, Koreatowns, and Indian business districts, as well as Hasidic neighborhoods, Amish communities, and longstanding ethnic enclaves across the East Coast and beyond. In this respect, Michigan and many of the states mentioned in our report are not outliers but representative of the richness of American diversity. Yet, white Christian nationalists put Muslim Americans in the crosshairs of violent disinformation that positions them as a civilizational threat.

In our quantitative data set, we found **51.3k** Islamophobic posts centered on and based in Michigan.

Our team's manual coding¹⁰ identified “Muslim invasion” and related claims that Muslims pose a demographic threat as the dominant theme, appearing in 70% of posts. The next most common theme was the alleged imposition of Sharia law, cited in 42% of posts, followed by assertions that Islam and Muslims are incompatible with America, present in 23%. Calls for the deportation of Muslims appeared in 19% of posts, while content saying Islam attacks Christians appeared in 14%.

moves into offline provocation—through incendiary appearances at city council meetings, orchestrated moments of bigotry, and marches or other stunts designed for virality. These actions are then amplified online, ultimately contributing to policy changes, heightened surveillance, harassment, and other forms of targeting against Muslim and immigrant communities.

Influencers like Matt Walsh, Amy Mek, and Laura Loomer frame Michigan as the frontline in the so-called “Islamification of America.” Walsh laments visible signs of diversity in Dearborn and deploys frequent dog whistles to white nationalist audiences about

Political and media rhetoric has repeatedly contributed to the stigmatization of Muslim communities in Michigan. At the height of the 2024 electoral cycle, Steven Stalinsk of the Islamophobic think tank [Middle East Research Institute](#) published an [opinion piece](#) in the Wall Street Journal labeling Dearborn as “America’s jihad capital.” While the article was published in 2024, its continued influence in 2025 underscores how irresponsible media framing can erode trust and deepen divisions long after the initial publication.

Such sensationalized language can legitimize Islamophobic attitudes, provoke online harassment, and create real-world safety concerns that force local authorities to increase police protection around Muslim spaces. Agitators have paraded through Arab American festivals [carrying a pig's head](#) mounted on a pole, and some Christian evangelists routinely position themselves in parks and outside schools [to target Muslim children](#) for conversion efforts.

Dearborn presents a clear example of how right-wing influencers have perfected a cycle that begins with online outrage and

the city's Muslim community, casting ordinary civic and cultural life as evidence of an existential threat. In this narrative, all Muslim elected officials and candidates are inherently suspect.

The current mayor, Abdullah Hammoud, has become a particular target. His openness about his faith and identity, along with the visible presence of Muslim leaders in city government, has been used to fuel discriminatory attacks.

Recent city decisions, such as permitting the call to prayer and allowing religious processions, have drawn intense criticism from the right. Even [Mayor Hammoud's](#) announcement of the expansion of the statewide Michigan program [Rx Kids](#) to Dearborn, which provides support for families with newborns, has been framed by extremists as part of a "Muslim replacement" agenda rather than recognized as a typical pro-family policy that benefits a growing community.

Amy Mek is an American far-right activist, prominent critic of Islam, and social media influencer. She is the founder of the [RAIR Foundation USA](#) (Rise, Align, Ignite, Reclaim), a right-wing platform focused on immigration, anti-Muslim narratives, left-wing politics, and "globalism." Over the past year, her X/Twitter account has been a prolific source of provocative and bigoted content, driving Islamophobic narratives across multiple states.

Mek has amplified a vision of Muslims in Michigan as an existential threat, repeatedly declaring that "Michigan has fallen" and warning of the "Islamification" of the state. In her framing, Muslim elected officials are on the frontline of an



alleged war against the United States. She has described Michigan as the “template for America,” claiming that Muslims will “seize neighborhoods, then politics, then law—city by city,” and asserting that from “Michigan to Minnesota to Texas, the model repeats: enclaves, political capture, Sharia normalized.”

These incendiary posts are crafted to inflame outrage around a fictitious “civilizational war,” helping normalize conspiratorial, anti-Muslim narratives in mainstream discourse.

In Hamtramck and Dearborn Heights, Michigan, the Muslim Brotherhood's plan for civilizational jihad is playing out openly.

A Muslim man brags:

In 2022, Hamtramck became the first U.S. city to have an all-Muslim city council. Mayor Amer Ghalib has accused Arab leaders of being “secret Jews,” endorsed rhetoric calling Jews “monkeys,” and oversaw renaming the city's main street “Palestine Avenue” to celebrate October 7.

In August 2025, council members Mutasen Sadman and Muhammad Hassan were charged with election fraud—yet media silence continues.

Dearborn Heights: Another Domino

Next door, Mayor Bilal “Bill” Bazzi (elected 2021) presides over a city rapidly becoming an Islamist enclave—mosques, halal businesses, hijab murals, and neighborhoods advertised as places where “everybody is Muslim.”

The Template for America

This is not “diversity.” It's the Brotherhood's strategy: seize neighborhoods, then politics, then law—city by city.

From Michigan to Minnesota to Texas, the model repeats. Enclaves. Political capture. Sharia normalized.

America is watching murals, mosques, and mayors become the frontlines of civilizational jihad.

Laura Loomer is another American far-right political activist, conspiracy theorist, and internet personality. Based in Florida and originally from Tucson, Arizona, she has worked with a range of extremist and right-wing outlets, including Project Veritas, the Geller Report, Rebel News, and InfoWars. She is now a high-profile influencer within Trump-aligned networks and frequently targets states with significant Muslim populations, including Michigan.

Alongside alt-right provocateur and self-styled journalist Cam Higby, as well as other Turning Point USA and PragerU-affiliated personalities, Loomer has repeatedly framed Michigan's Muslim-majority communities as evidence of a broader "Muslim invasion." In one representative post, she asserts: "The Islamification of America is a national security threat. We need to address this before the midterms or else America will become a Muslim country."

These posts are not isolated outbursts; they are part of a coordinated narrative strategy. By casting ordinary Muslim civic life as a national security crisis, Loomer and other bigoted influencers signal how Islamophobia is a key wedge issue for the right in the 2026 midterms—mobilizing fear, legitimizing discriminatory policies, and justifying intensified surveillance and exclusion of Muslim communities.



Perhaps the most significant flashpoint in Michigan was created by Jake Lang, a right-wing influencer and founder of the provocateur group “Americans Against Islamization.” Lang was arrested ten days after the January 6, 2021, Capitol riot and charged with assaulting law enforcement. He spent nearly four years in federal custody without trial while contesting the charges, including approximately 900 days in solitary confinement at Washington, D.C.’s Central Detention Facility, before receiving a presidential pardon in January 2025.¹¹ Lang is running as a Republican for a U.S. Senate seat in Florida.

Over the past year, Lang has organized a series of highly performative events designed to generate viral outrage against Muslims. These actions typically begin with a call to “march,” then escalate into direct attacks on Muslim communities or Muslim elected officials in multiple cities, including legal harassment such as [suing Zohran Mamdani](#).

Lang’s activities exemplify a manufactured crisis: a deliberately staged cycle of provocation intended to attract attention, drive engagement and donations, and further

normalize Islamophobic narratives in the broader right-wing media ecosystem.

Jake Lang's profile rose dramatically on November 18, 2025, with his "March Against Islamification" in Dearborn. Popular conservative influencers such as Cam Higby, Lang himself, and figures associated with Charlie Kirk's Turning Point USA participated in the rally. Emotions were particularly high in the wake of [Charlie Kirk's murder](#) on September 10, 2025, which has increased white nationalist provocations across the country.

During the event, participants shouted racist abuse, unfurled a banner reading "Americans Against Islamification," and staged provocations such as striking a Qur'an with a slab of bacon, claiming that "Michigan has fallen," and Americans are marching to "take Dearborn back".

Lang, prominently posing with a large cross, used the march to antagonize local residents and generate viral soundbites. The event culminated in an orchestrated takeover of a city council meeting by Lang and other right-wing provocateurs, where they delivered incendiary speeches carefully designed for maximum online amplification. Lang said the following:

*"You marry 4 or 5 women, you outbreed us, you change the laws, you make all of our country look like the places that you fled from. [We don't want you here. Respectfully, get the f*ck out of my country.](#)*

I don't want you here. Get out of here. This is our country, and the people and veterans whose blood has soaked our constitutional republic are looking around Europe, and they are looking around America and saying, What the hell did we fight for? We have been taken over without a single shot fired.

You guys are outbreeding us, insidious parasites on the American way of life. You will never look like us, you will never eat like us, you won't build buildings like us. You are nothing, and you cannot build anything. You will never be nothing, just like President Trump says. You guys are not us. America first. Americans only. God bless America. Jesus is king."

This speech went viral nationwide, prompting major right-wing influencers like Matt Walsh to weigh in. In its wake, a group of bikers organized a ride through Dearborn framed as an effort to "assert the rights of Americans," further stoking tension and spectacle. The staged [city council video](#) has been viewed millions of times across multiple platforms. The crowd's reaction to the march and the council meeting was selectively filmed and edited to depict Muslim residents as aggressive and threatening.

Such racist content has helped trigger a cascade of similar videos online, further normalizing and spreading Islamophobic narratives. Jake's content is significant because it reflects a broader pattern across the Islamophobic material: it creates a pathway for mainstreaming white Christian nationalist framing. Much of the content explicitly uses Christian nationalist slogans (e.g., "Christ is King") and symbolism (e.g., Crusader or "Crusades" imagery) to cast Muslims as a hostile or incompatible "other" and to position the United States as a fundamentally Christian nation under siege. Such rhetoric is not limited to Jake's posts; it is a consistent trend across the entire dataset.

INTRODUCTION
This action arises from one of the most shocking displays of deliberate constitutional abandonment ever carried out by a municipal government on American soil. On November 18, 2025, the City of Dearborn and its political and law-enforcement leadership knowingly and intentionally refused to protect peaceful American citizens—including Plaintiff Edward J. "Jake" Lang—as they were violently attacked, stalked, threatened, and hunted for hours in the streets of Dearborn, Michigan.

For nearly seven consecutive hours, Defendants enforced a discriminatory "stand-down" directive that left Plaintiffs exposed to escalating mob violence. Dearborn Police Officers stood idle, watching without intervention as hostile counter-protesters launched assault after assault: pepper spray attacks, property destruction, sucker-punch assaults, thrown projectiles, food attacks, gravel attacks, and finally a direct, on-camera threat to murder Plaintiff Lang and his family.

He now plans to travel to other cities, and other influencers are using his viral moment to advance their own profiles and agendas. One immediate consequence of this renewed wave of Dearborn-focused Islamophobia has been escalating calls for ICE involvement and immigration raids targeting the city’s Muslim communities.

In addition, bots sharing identical text have significantly amplified hate speech. Dozens of handles repeatedly posted the same content across multiple accounts, as illustrated in the example below. This coordinated activity not only magnified the reach of Islamophobic content but also created a false impression of broad, organic public support for these narratives.

In response, the Dearborn mayor convened a unity-focused press conference to reaffirm the city’s commitment to inclusion and community safety. Even so, Dearborn continues to serve as a flashpoint in the national discourse on Muslim civic life and Islamophobic disinformation at the time of this writing.

Mirroring broader attacks on Muslim communities, Representative Rashida Tlaib has faced sustained Islamophobic targeting since entering Congress. In 2025, she was repeatedly in the crosshairs of "Muslim invasion" narratives, with posts labeling her a terrorist, blaming her for Dearborn's diversity, demanding her removal from office, and, in some cases, issuing explicit threats and calls for violence.

The persistence and severity of this targeting of Rep. Tlaib and other Muslim elected officials has been widely noted, including the often insufficient institutional response and inconsistent support from Democratic leadership. As early as 2019, Rep. Tlaib warned that "Islamophobia was present on both sides of the aisle."¹² This dynamic resurfaced during the 2025 New York City mayoral race, when the four Muslim members of Congress issued a joint statement: "The vile, anti-Muslim and racist smears from our colleagues on both sides of the aisle attacking Zohran Mamdani cannot be met with silence. These hateful, Islamophobic, and racist tropes have become so entrenched and normalized in our politics," said Reps. Andre Carson of Indiana, Rashida Tlaib of Michigan, Ilhan Omar of Minnesota, and Lateefah Simon of California.¹³ As we head into the midterms, a key



Texas

Islamophobic narratives in Texas focus on the growth of Muslim communities in the state and the construction of mosques. A familiar pattern appears: the visible presence of religious observance, hijab, Arabic street names, and other ordinary markers of Muslim life are misrepresented as evidence of a “Muslim invasion.” According to the Texas Almanac, the estimated number of Muslims in the state increased to 421,972, making it the fifth largest religious group in the state and making Texas first in the nation in the number of Muslims.¹⁴

In our quantitative dataset, our team found over **279k posts** generating and engaging in narratives related to Islamophobic content in Texas.

From our manually coded¹⁵ content, we found that the most common narrative frame was Muslim invasion and Islam as a demographic threat, with 71% of all posts reflecting this theme. Calls to investigate Muslim organizations and leaders comprise 58% of posts and claims about the imposition of Sharia law in Texas, 35%. Less frequent but still notable narratives include assertions that Islam is incompatible with American values (21%) and allegations that Muslims are using government subsidies (17%).





In recent years, conservative influencers, most notably Amy Mek, have published multiple “exposés” targeting a major mosque development in Plano, framing it as evidence of “creeping Sharia.” Since her initial post about the project, she has produced numerous follow-up posts about the development, tagging government officials and amplifying local protests against the mosque that were, in many cases, sparked or escalated by her coverage. 



Jake Lang also brought his Islamophobic theatrics to Texas, where he organized a protest in Plano, Texas, holding a Qur'an stuffed in a pig's head and posted videos burning a Qur'an to fry bacon.¹⁶ A central feature of his staging is the white Christian nationalist slogan displayed on his lectern: "Deus Vult." As Crusades historian Dan Jones notes, the Latin phrase "Deus Vult," meaning "God wills it," was a battle cry associated with the First Crusade, which lasted from 1095 to 1099. In contemporary extremist ecosystems, it has reemerged as a marker of white supremacist and hard-right identity, frequently visible at extremist marches and embedded in online "Crusader" meme culture, including images of Knights Templar paired with captions such as "I'll see your jihad and raise you one crusade."¹⁷ In this context, its use functions less as historical reference than as coded mobilization language that signals and legitimizes white Christian nationalist hostility and, at its most extreme, violence.

A recurring Islamophobic provocation is the claim that communities with large Muslim populations are inherently hubs of terrorism. One prominent example is an episode of The Going Rogue podcast hosted by Lara Logan, previously banned from Newsmax for incendiary commentary,¹⁸ featuring former FBI agent John Guandolo. The episode advances conspiracy claims by presenting a list of U.S. cities and states purported to have the “most Islamic jihadist activity.” He asserts that Texas was a national hub, with Dallas and Houston named the single worst cities in America for the joint Islamic-Communist movement. Additional cities included Dearborn, Minneapolis, St. Paul, and others. Logan also identifies USAID as a primary source of “jihadist funding,” without credible evidence.

The episode's significance lies not in its plausibility, but in its reach: clips from the podcast continue to circulate, with the trailer on X receiving over 450K views and the YouTube channel 23K views. Its virality illustrates how inciting, stigmatizing content continues to spread widely in Texas and beyond, reinforcing the false association between Muslim civic presence and terrorism.

All of these narratives together helped fuel an online atmosphere of hysteria, which in turn generated political pressure for state action. Governor Abbott subsequently announced multiple investigations, while Mek continued to publish additional “investigations” that further inflamed public sentiment.

Below is a timeline documenting the escalation of disinformation from Amy Mek alongside the policy announcements that followed. Together, these developments underscore a consistent pattern across our dataset: viral hate speech and disinformation frequently translate into discriminatory policy responses, targeting Muslim immigrants, civil society organizations, elected officials, and voters. The problem is likely to intensify as the midterms approach.

At the electoral level, candidates like Valentina Gomez have built entire platforms around banning Islam, using highly provocative content—such as videos of her burning the Qur'an¹⁹—to attract attention and support. While it remains to be seen how this will translate at the polls, the traction she has gained underscores how normalized and politically instrumentalized Islamophobic hate has become in parts of Texas and across the country.

As the nation heads into the midterms, the disinformation will only continue to grow to even more proactive and dangerous hate speech.



Minnesota

Minnesota is often associated with its Scandinavian immigrant roots and civic traditions shaped by Nordic settlement, Lutheran institutions, and a strong public-sector ethos. At the same time, the state is undergoing a significant demographic shift. The Twin Cities have become a major destination for new immigrant communities, including one of the largest Somali Muslim populations in the United States. Among foreign-born Somalis in Minnesota, 87% are naturalized U.S. citizens, and nearly half arrived in 2010 or later, reflecting continued migration driven by Somalia's prolonged civil war and the draw of Minnesota's social supports. The largest concentration is in the Minneapolis-St. Paul region, home to roughly 84,000 Somali residents.²⁰ This increasingly diverse population has enriched Minnesota's cultural and political landscape. Still, it has also made Muslim communities a focal point for organized Islamophobic and anti-immigrant narratives that seek to cast inclusion and pluralism as threats to the state's identity.

In our quantitative dataset, our team found over **14.9k posts** originating and engaging in narratives related to Islamophobic content in Minnesota.

Top 5 themes of Islamophobic Disinformation in Minnesota

Theme	Percentage
1. Muslim Invasion / Demographic Threat	52%
2. Calls to deport Muslims / Anti-immigration	42%
3. Vilifying countries of origin	41%
4. Degrading slogans and dehumanization	29%
5. Criminalization of Muslims	20%

As in all five states analyzed, the narrative around “Muslim invasion” and Muslims as a demographic threat in Minnesota was the top theme online, with 52% of total posts reflecting this sentiment. 42% of posts from the state called for deporting Muslims, and 41% vilifying the countries of origin of those users considered to be non-natural U.S. citizens—meaning immigrants. In comparison, 29% of posts from the state used degrading and dehumanising slogans against Muslims, and 20% criminalized Muslims. Islamophobia in Minnesota is closely tied to the state’s large Somali Muslim community. Minnesota is home to more than 114,590 Muslims, many of whom are Somali. Nationally, an estimated 260,000 people of Somali descent lived in the United States in 2024 (U.S. Census Bureau, American Community Survey), including approximately 107,000 in Minnesota—about 2% of the state’s total population.²¹

The prominence of Somali voters and their elected officials has led to a barrage of racism and Islamophobia by the white nationalist right wing. This dynamic has been visible for years, particularly since Ilhan Omar’s election to Congress. The powerful Black and Brown Muslim electorate that helped bring her into office has also suffered sustained attacks on the broader civil society infrastructure that supports Muslim political participation at all levels of government.

Minnesota-centered Islamophobic content in 2025 came in several waves. The first began with Omar Fateh's mayoral candidacy. Omar Fateh's 2025 Minneapolis mayoral bid was historic because, as a young democratic socialist, he upset an incumbent mayor (Jacob Frey) to win the crucial Democratic-Farmer-Labor (DFL) party endorsement.²²

This endorsement was a rare feat, demonstrating strong grassroots power; however, it was later revoked due to voting system issues, creating a uniquely unpredictable race. His campaign—backed by progressives, DSA, and diverse voters—challenged the political establishment in a city known for its activism and global awareness, making his run a significant moment in progressive politics, despite the complex outcome. During his candidacy, his campaign faced sustained racist attacks targeting his Somali background, his appearance, and his faith, with influencers like Matt Walsh, Charlie Kirk, Amy Mek, Laura Loomer, and many others weighing in from across the country. The distinctly anti-Black character of this rhetoric is notable, including repeated references to “shithole countries”—language mainstreamed in political discourse.



Efforts to name the white supremacist and racist nature of the attacks on Omar Fateh were repeatedly met with further demeaning and dehumanizing rhetoric. After Fateh's loss, a new narrative gained traction following a November 19, 2025, right-wing report by Ryan Thorpe and Christopher F. Rufo.²³ They alleged welfare fraud by a small number of individuals—claims then generalized to imply that the broader Somali community was systematically defrauding the state and funneling money to terrorist organizations, stoking anger between white and other racialized communities against Somalis in the state.²⁴ Compounding this, YouTube “gotcha” videos by Nick Shirley claimed to have uncovered more than \$110 million in fraud. Although these allegations have been debunked, the content continues to circulate, alongside a broader wave of hate targeting Somali daycare providers, many of whom have reported harassment and death threats in the aftermath of these videos.^{25, 26}







This narrative was quickly weaponized online to depict Somalis as uniquely “entitled” and parasitic, reinforcing racist and Islamophobic stereotypes of criminality and casting doubt on the legitimacy of a Black Muslim community. This is evidenced in the results of our research, where vilification of countries of origin and criminalization of Muslims emerged as part of the top five themes in the state. The result has been a sustained, months-long wave of anti-Somali and anti-Muslim memes and propaganda.



Like many Minnesotans, I was glad to turn the page on 2025. It was an extraordinarily difficult year for our state. And it ended on a particularly sour note.

For the last several years, an organized group of criminals have sought to take advantage of our state's generosity. And even as we make progress in the fight against the fraudsters, we now see an organized group of political actors seeking to take advantage of the crisis.

I won't mince words here. Donald Trump and his allies – in Washington, in Saint Paul, and online – want to make our state a colder, meaner place.



As of this report's publication, the fallout in Minnesota continues, including the killing of activist Renee Nicole Good, who participated in community-based ICE defense efforts, and escalating tensions as ICE deployments expand and President Trump threatens to invoke the Insurrection Act. Minnesotan communities are responding with courage and solidarity, and our team will continue to monitor developments as the situation evolves.

Florida

Florida is home to an estimated 127,172 Muslims, about 0.6% of the state's population, which ranks the state 12th nationally by Muslim population size. Florida's Muslim communities are geographically widespread, supported by more than 150 mosques and Islamic centers serving residents from the Keys to the Panhandle. The population is also notably diverse: roughly 31% are U.S.-born, while 69% trace their origins to other countries and regions, including Pakistan, India, Egypt, Palestine, Guyana, and Puerto Rico.²⁹

In our quantitative dataset, our team found over **150k** posts generating and engaging in narratives related to Islamophobic content in Florida.

Our manual coding³⁰ reveals that the prevailing Islamophobic narrative in Florida centers on the Muslim invasion, consistent with broader national discourse. This theme made up 65% of total posts from Florida. Calls to investigate Muslim organizations and leaders came next at 26%. Users used degrading and dehumanising slogans in 23% of posts. The fear of the imposition of Sharia law in Florida followed at 21%, while 18% called for the deportation of Muslims and were anti-immigration.




This Arabic-language recruitment video, translated and subtitled by RAIR Foundation USA, openly instructs Muslims how to relocate to Tampa and live entirely within Muslim Brotherhood institutional networks.

This is not my analysis. This is their plan, in their own words.

“The first place we will visit is the mosque, and from the mosque we will learn about the situation of Arabs through the imams there.”

That statement matters.

In Muslim Brotherhood doctrine, the mosque is not simply a place of worship. It is the organizational gateway, where population strength is communicated, trust is established, and families are routed into aligned schools, businesses, and services.

The featured mosque is Masjid al-Qassam, named after Izz ad-Din al-Qassam, the ideological forefather of Hamas.

“The population of Tampa was 10,000 in the year 2000. Now it is 175,000 from the Arab community... 70% of the population present are Arabs.”

This claim is being used as a recruitment signal, telling incoming families the infrastructure is already in place and that assimilation will not be required.

“I certainly advise anyone looking for Islamic schools... who wants an Arab and Islamic environment.”

This is the next step in the Brotherhood model.

Directly across the street from Masjid al-Qassam sits the American Youth Academy (AYA), one of Florida's largest Islamic schools, now receiving taxpayer funding through Florida's voucher programs.

AYA is the rebranded continuation of the Islamic Academy of Florida, founded by individuals later convicted in federal court of providing material support to Palestinian Islamic Jihad.

“I have visited 28 states and have not seen anything like this. This school gives you the feeling of your homeland, as if you are still in your country.”

That is not supplemental education. That is continuity by design.

For years, Muslim Brotherhood operatives themselves have described schools as the primary long-term asset, where identity is shaped, loyalty is reinforced, and future voters, candidates, and institutional leaders are cultivated from childhood.

That doctrine is visible here.

Then comes the economic spine.

“Everything an Arab household needs, you will find it right here.”

Markets beside the mosque import 90% of products from Palestine, promote BDS boycott alternatives, ship nationwide, and operate entirely within halal, Sharia-regulated commerce — a closed economic loop.

Then comes permanence, underwritten by taxpayers.

“The insurance is the marketplace insurance... it is subsidized by the government... there are people who pay \$0.”

Government-subsidized healthcare is openly advertised as a relocation incentive.

This is institutional replication, consistent with the Muslim Brotherhood's own documented strategy: schools first, population consolidation second, political influence third.



For several years, Chris Svochak,³¹ or “Saint Chris,” has produced provocative content in which he confronts Muslim students on campus: bringing bacon to deliberately offend, striking or mishandling the Qur'an, and preaching extremist Christian nationalist views that explicitly invoke hostility and violence. During a [livestream](#) by Warriors for Christ, an organization [recognized by the SPLC](#) as a hate group, Muslim students were filmed kneeling in prayer; one of the men, identified in the video only as Ricardo, approached with a painted cardboard box that read “KAABA 2.0 JESUS IS LORD.”³² During this harrowing encounter, the men harassed and intimidated the students as they prayed, shouting that “the Prophet was a pedophile” and demanding that they “confess their sins” and stop “praying to a false prophet.” When the students continued praying and refused to engage, the men repeatedly escalated their abuse, insulting the Prophet Muhammad PBUH and God, telling the students they were “going to hell,” accusing


them of loving “evil,” “wickedness,” and “sin,” and taunting them by offering bacon while cursing at them and their religion.

Even press conferences held in the wake of these hate crimes have been ridiculed online. Posts highlighted a student who supported the mocking of victims, issued calls for violence, and denounced the decision to charge perpetrators with felony hate crimes.

Against this backdrop, Florida legislators—and some members of Congress—have introduced proposals to “ban Sharia law,” attempting to codify Islamophobic conspiracy theories into policy and thus legitimizing the underlying conspiracy. Republican state Rep. Hillary Cassel filed a bill (HB 119)³³ aimed at preventing courts and government agencies from considering or enforcing Sharia law or any foreign legal system, even though there is no movement or actual use of Sharia law in the state’s legal system; civil rights groups including the Council on American-Islamic Relations (CAIR) have denounced the proposal as rooted in fear-mongering and bigotry rather than an actual legal problem.³⁴ At the federal level, Florida Representative Randy Fine and Texas Representative Keith Self introduced the “No Sharia Act,” which would bar U.S. courts from enforcing judgments or decisions based on Sharia or other foreign laws that allegedly conflict with constitutional rights—a proposal its sponsors say is needed to protect “Western culture” and the supremacy of the U.S. Constitution.³⁵


Given Florida's pivotal role in national electoral politics, we anticipate that these attacks will continue, and our team will continue to monitor them.

California

California, one of the largest Democratic-led states in the country, is not typically viewed as a statewide political battleground. Several of its congressional and legislative districts remain highly competitive, however, making the state an important testing ground for national midterm strategies. California has one of the largest Muslim populations in the country. The estimated number of Muslims in California in 2025 is 504,056, representing around 1.3% of the population.³⁶ Our research found that even within a stronghold of Democratic governance, Islamophobic disinformation circulates at scale, driven by conspiratorial memes that target Muslim immigrants and Muslim-led nonprofits. These narratives are not confined to fringe spaces; they routinely frame routine civic participation and community institutions as security threats, fueling stigma and building political pressure for restrictive measures.

In our quantitative dataset, our team found over **117k posts** generating and engaging in narratives related to Islamophobic content in California.

In our manually coded³⁷ dataset, California, like the other states, had Muslim invasion as the primary theme at 47%. Calls to investigate Muslim organisations and leaders followed closely at 35%, and calls to deport Muslims was at 10%. The supposed imposition of Sharia law and the criminalization of Muslims appeared at 9% and 8%, respectively.

A common meme expressed shock and disgust at the number of mosques in the Los Angeles region. Variations of this content appeared across multiple states, including Texas, Michigan, and Florida, often relying on a simple Google Maps zoom to create the impression of a widespread “invasion.” This was one of the most prevalent meme formats in both the California sample and the national dataset.







Office holders and gubernatorial candidates in the state also engage in fear-mongering against the Muslim community, linking them to violence and terrorism.

These narratives are reinforced not only by online influencers but also by political and public officials. For example, San Luis Obispo County District Attorney Dan Dow reshared posts on X that linked the election of New York's first Muslim mayor, Zohran Mamdani, to the 9/11 attacks, using imagery and commentary that implied an inherent threat from Islam. In the same vein, gubernatorial candidate Steve Hilton attempted to tie Somali fraud conspiracies to Governor Gavin Newsom's spending policies, pledging to pursue audits and investigations.

Muslim candidates are also directly targeted. Green Party candidate Butch Ware, a prominent progressive Muslim leader focused on racial justice and labor rights, has been branded a "jihadi" in multiple right-wing memes.



The Washington DC Shooting

On November 26, 2025, a shooting in Washington, D.C., in which two U.S. National Guard members were shot, one of whom later died, triggered a notable increase in anti-Afghan sentiment online and in public discourse.

The alleged shooter was identified as an Afghan national who entered the United States in September 2021 through Operation Allies Welcome, launched by the Joe Biden administration aimed at evacuating and resettling Afghans, who had worked with American forces after the U.S. military's withdrawal in August 2025.⁴⁰ This fact quickly became a focal point of online discussion and political commentary.

Following the shooting, high-profile figures, including President Donald Trump, used social media and official statements to link the incident to broader immigration issues. The President called for stricter migration policies and broader suspension of immigration from "third world countries," directly associating the actions of the suspect with Afghan and other immigrant communities. "We must now re-examine every single alien who has entered our country from Afghanistan under Biden, and we must take all necessary measures to ensure the removal of any alien from any country who does not belong here, or add benefit to our country. If they can't love our country, we don't want them."⁴¹

New measures, including pausing asylum rulings and stopping new immigration applications from Afghan citizens, quickly became the subject of intense online debate.





In response, President Trump expanded U.S. travel restrictions to more than 35 countries. Effective January 1, 2026, the revised policy fully blocks travel for individuals from Syria, South Sudan, Niger, Mali, and Burkina Faso, as well as for those holding documents issued by the Palestinian Authority. It also imposes partial restrictions on individuals from 15 additional countries, primarily in Africa.⁴²

The expansion significantly restricts legal immigration, affecting not only new entrants but also spouses, children, and parents of U.S. citizens, as well as Afghan Special Immigrant Visa holders who assisted U.S. forces. It further limits admissions for siblings and adult children of U.S. citizens and international students. In total, the policy now fully or partially restricts travel from nearly **20% of the world's countries**, tightening constraints even on nations previously subject to partial bans.

This episode also underscores a persistent double standard in how violence is interpreted and politicized, particularly online. When a perpetrator is perceived as Muslim or immigrant, discourse often rapidly expands from the incident itself into broad claims about immigration, asylum, and national security, fueling suspicion toward entire communities and legitimizing sweeping punitive policies. When perpetrators are white, however, violence is more often treated as an isolated event, explained through individual circumstances such as mental health or personal history rather than group identity. This asymmetry entrenches Islamophobic and anti-immigrant narratives and shapes public understanding in ways that normalize exclusion under the guise of safety.



Conclusion

The scale and intensity of Islamophobia documented in 2025 are deeply alarming, and it is understandable if readers come away feeling discouraged or even overwhelmed. Yet this report also tells another story, one of resilience. Across the country, Muslim, immigrant, and other targeted communities, including racial, religious, and gender and sexuality minorities, continued to organize, vote, run for office, participate in public meetings, and care for one another in the face of sustained hostility. A clear example is the election of Zohran Mamdani as the Mayor of NYC. Most of his team and the organizers who pulled off this historic electoral upset are Muslim-Americans.

That is why documenting this harm matters. Clear evidence equips communities, institutions, and policymakers to recognize how online hate escalates into real-world intimidation and discriminatory policy. It also strengthens the capacity of those most affected to create spaces for healing, build civic power, and develop strategies to protect participation in public life.

We are especially encouraged by leaders and candidates who refuse to let bigotry dictate the terms of politics, and who choose long-term vision over endless cycles of reactive crisis management. As newly elected officials take office and begin governing amid these pressures, we offer this report and its recommendations as a practical roadmap to disrupt electoral Islamophobia, increase accountability, and safeguard the right of every community to participate fully and safely in American democracy.

Here are recommendations from our study to help prevent this harm and mitigate its further effects on our communities:

Recommendations

1. **Define all faith-based electoral disinformation as a civil rights and voter access issue.** Treat anti-Muslim disinformation, intimidation, and targeted harassment of candidates and voters as an election access and equity issue with clear response protocols to ensure fair and equitable elections.
2. **Implement more rigorous platform enforcement during election cycles.** Create more rapid takedown/escalation channels for election-related hate speech and disinformation, limit recommendations or reach for repeat offenders, and apply consistent penalties, including demonetization. What exists is insufficient to deal with what is occurring on all platforms. These protocols should apply not only to English-language content in the U.S. electoral context, but should be localized and developed for each of the different languages, cultures, and regions a platform serves, as many of the issues we describe here repeat globally and are gravely under-addressed.
3. **Protect Muslim candidates, election workers, and community leaders.** Provide threat monitoring, doxxing response, security planning, and legal support (with standardized reporting pathways and referrals for credible threats) to all Muslim candidates, election workers, and community civic engagement organizations.
4. **Shut down provocation-for-virality in civic and election spaces.** Strengthen rules and enforcement at city councils, school boards, marches, and polling sites to prevent harassment, filming-as-intimidation, and coordinated disruptions.
5. **Increase transparency for political influence and “soft ads.”** Expand disclosure requirements for funders, targeting, and AI-generated content across political ads and influencer-style issue content; maintain searchable, publicly accessible ad libraries.
6. **Disrupt the funding and networks behind Islamophobic campaigns.** Demonetize repeat hate actors pushing Islamophobic narratives, enforce brand-safety standards, and identify coordinated networks that generate offline confrontations to drive online harassment.

7. **Inoculate communities with rapid, trusted information through prebunking.**
Fund multilingual voter-information and prebunking campaigns, equip local partners with rapid response toolkits, and operate clear reporting channels for intimidation and disinformation.
8. **Consistently enforce laws against threats, stalking, and voter intimidation.**
Prioritize the prosecution of credible threats and online-to-offline escalation, improve evidence preservation and data sharing, and coordinate civil rights enforcement across jurisdictions.
9. **Establish and resource multi-racial, interfaith coalitions to counter the mainstreaming of white Christian nationalism** through coordinated public education, rapid response, civic engagement, and community safety initiatives.
10. **Fund and support existing community-led safety initiatives for impacted Muslim communities** that resource leaders, organizations, religious institutions, and allies to build mutual aid, digital security/disinformation support, and community safety networks. These programs should prioritize prevention, care, and resilience while avoiding expansion of surveillance or policing infrastructures.

Appendix A: Methodology

To trace Islamophobic narratives in 2025, we used a rigorous mixed-methods design that integrated quantitative scale analysis with qualitative interpretation. Using a social listening tool and structured keyword queries, we assembled a cross-platform dataset of public posts for quantitative measurement, then conducted qualitative content analysis to identify narrative patterns, themes, and indicators of dangerous speech. Grounded in the conceptual framework developed in our research, we refined and updated our keyword set and collected posts published between January 1 and December 31 across 12 platforms. The Boolean query below was used to focus review on the content most directly relevant to dangerous speech:

For this report, our team of experts employed a mixed-methods approach, combining:

- **Quantitative analysis** using social media intelligence tools to track volume, engagements, and patterns of Islamophobic disinformation around the theme of “Muslim invasion” across 12 social media platforms³⁹ as well as manually coding a set of over 1500 posts.
- **Qualitative analysis** through a hand-coded review of content across our dataset, allowing us to identify narratives, frames, and tactics that cannot be captured by metrics alone.

Together, these methods provide both a broad overview of the disinformation ecosystem and a granular understanding of how specific messages were constructed, targeted, and amplified across the United States, particularly in five battleground states.

Appendix D: Islamophobic Themes

This section presents a description of the full range of disinformation themes observed across our dataset. Below is an analysis of the content with examples of each theme.

Muslim invasion / Demographic threat: The idea of a “Muslim invasion” or Muslims as a “demographic threat” is a political narrative that frames Muslim immigration or population growth as dangerous to a nation’s culture, identity, or security. It is widely criticized for being misleading and for promoting fear or hostility toward Muslims rather than reflecting evidence-based demographic or social realities.
